

# 2015 Remedy Data Collection Update for Employers: volumes of affected members

Following on from our last communication sent in July, we can now share the total number of impacted members per employer. You can find these on the next few pages. As you are aware we will need the following information for all impacted members during the period 2015 - 2022:

- Pensionable earnings, including assumed earnings where appropriate\*, for members who stayed in classic, classic plus and premium
- Widow/er Pension Scheme (WPS) contributions for alpha members who migrated from classic

This will be required by the Scheme Administrator (MyCSP) for all impacted members.

As advised in previous communications, the approach has been changed to collect data from the members' relevant employer. This revised approach has slightly increased the overall volume of data requests for collection as data may be needed for the same member from several employers.

The data required for impacted members will be collected by the Scheme Administrator (MyCSP) in two phases following a Pilot Phase. Timelines for Phase 1 and 2 are shown below.

From January 2022 we will start collecting data for those members who, as of 31 March 2020, are:

- Deceased
- Deferred
- Pensioners including partial retirees

For all remaining in scope members, the data collection exercise will begin in July 2022.

We are engaged with several employers who agreed to be part of a pilot exercise and are on target to undertake this exercise starting late September 2021. From the pilot, we hope to identify any challenges and improvements prior to full roll out. We will keep you informed about how the pilot progresses.

#### What to do next

You will need to review the amount of your members who will be affected by the 2015 Remedy, you should start to consider what resources you need in order to provide the additional data needed by the Scheme Administrator (MyCSP).

We will ensure you have the necessary information and that appropriate support is in place. This will include guidance and account managers to respond to any queries, before data collection begins to enable you to plan appropriately for this exercise.

### How to get help

The Scheme Administrator (MyCSP) will be running free support sessions for employers that will provide a forum for any questions or concerns you might have. We will share details on these in the coming weeks.

## **Ongoing Statements of Work**

If you currently have existing Statements of Work outstanding to rectify other data issues, this may result in a number of data collections required in order to collect any revised data at a later date.
