Boost your retirement income with Added Pension and EPA


Added Pension is an amount of extra annual pension you can buy which is combined with your Civil Service pension when you choose to take it. It can be bought either by a single oneoff payment (lump sum) or regular monthly payments.

Effective Pension Age (EPA) allows you to take a portion of your alpha pension unreduced before your normal pension age. It's one of the ways alpha members can take control of their retirement planning.

If you're considering making additional contributions for the next scheme year (2026/27), please note that limits and deadlines apply. Your employer will confirm what these are soon, and information will be provided on the scheme website. You cannot apply until your employer has shared the limits and deadlines.

Minimum Pension Age Increase

The Finance Act 2022 introduced legislation which means that, for most people, the earliest they will be able o access private and work pensions will rise from 55 to 57. For Civil Service Pensions, some members are protected and others are not.
